### DIRECTIONS FOR USE

**MIXING:** To prepare for pesticide application fill spray tank one-half full with water and begin agitation. Add pesticide or fertilizer as recommended and then add SilEnergy while continuing agitation. Continue to agitate until tank is full and agitate before and during each application.

**RECOMMENDED RATES:** For use with acaricides, insecticides, fungicides, miticides, (Live-stock sprays): Use 2-6 ounces per 100 gallons of water. For use with herbicides (aquatic & terrestrial), defoliant, desiccants: Use 6-14 ounces per 100 gallons of water. In difficult wetting situations (such as hard water on mature waxy foliage) the higher rate may be required.
