FIRST AID:

DIRECTIONS FOR USE:

Mixing: To prepare for pesticide application fill spray tank one-half full with water and begin agitation. Add pesticide or fertilizer as recommended and then add Crop-Kick+ while continuing agitation. Continue to agitate until tank is full and agitate before and during each application.

Recommended Rates: For use with acaricides, insecticides, fungicides, miticides, (Live stock sprays): Use 1/4 to 1/2 pint (4 to 8 fl. oz.) per 100 gallons of water. For use with herbicides (aquatic & terrestrial), defoliants, desiccants: Use 1/2 to 4 pints per 100 gallons of water. In difficult wetting situations (such as hard water on mature waxy foliage) the higher rate may be required.
