## DIRECTIONS FOR USE

- Inject I'VOD C from a separate tank compartment (or its own container). Use various orifice sizes and valve settings for desired rate and volume.
- I'VOD C's oil to water phase can be varied over a range from 1-10 to 1-30, depending on the type of equipment and herbicides used.
- Be sure to read all label directions regarding herbicide-added-to-water phase. Do not exceed label instructions for the herbicide rate per acre.
- If invert breaks, check equipment for air leaks; then adjust water and invert oil orifices. Water quality and temperature can affect the invert.
- Contact your local dealer for additional instructions.
