## DIRECTIONS FOR USE

**MIXING:** To prepare for pesticide application fill spray tank one-half full with water and begin agitation. Add pesticide or fertilizer as recommended and then add SilEnergy+ while continuing agitation. Continue to agitate until tank is full and agitate before and during each application.

**RECOMMENDED RATES:** For use with acaricides, insecticides, fungicides, miticides, (Live-stock sprays): Use 2-6 ounces per 100 gallons of water. For use with herbicides (aquatic & terrestrial), defoliants, desiccants: Use 16 ounces per 100 gallons of water. In difficult wetting situations (such as hard water on mature waxy foliage) the higher rate may be required.
